


# The basic pricing plans available to you

## Plans at a glance

This table compares the different electricity bills for a hypothetical Jurong household in a four-room Housing Board flat if they had chosen a six-month contract in April based on if they had stayed with SP Group or switched to the two standard price plans offered by retailers. The tariff is adjusted every three months, and the average four-room household uses close to 400 kilowatt-hours (kWh) of energy a month. The discounts in the table were chosen based on the available range actually offered by retailers in Jurong.

<b>Things to note</b>	<ul style="list-style-type: none"> <li>The regulated tariff is set based on a fixed formula that reflects the long-term costs to produce and deliver electricity in Singapore.</li> <li>The regulated tariff is reviewed quarterly and approved by the Energy Market Authority.</li> </ul>	<ul style="list-style-type: none"> <li>The rate offered by the retailer may be higher or lower than the regulated tariff, which is adjusted quarterly.</li> <li>This plan is suitable for consumers who prefer certainty in the rate that they pay for their electricity consumption.</li> </ul>	<ul style="list-style-type: none"> <li>The discount offered is fixed, but the rate that consumers pay will change in tandem with the regulated tariff.</li> <li>This plan is suitable for consumers who do not mind the rate changing every quarter, so long as the rate is lower than the prevailing regulated tariff.</li> </ul>
